

# **Privacy Policy for Soma Hub**

# 1. Data We Collect

# 1.3 User Content

Users may upload files such as assignments, videos, and audio for coursework or services like transcription and OCR.

## 1.4 System Data

We automatically collect technical information, including:

- Device details (e.g., operating system, browser type)
- IP address
- Diagnostic and performance logs

# 2. How We Use Your Data

We use the data collected for the following purposes:

## 2.1 Providing Services

- Tailoring courses and educational materials to meet user needs.
- Allowing instructors to monitor learner progress and performance over time.

## **2.2 Parental Consent for Minors**

For users below the legal age, parental or guardian consent is mandatory. Schools facilitate this process, ensuring that learners comply with age-related regulations.

## 2.3 Payment and Licensing

- Individual students pay for courses directly through secure payment methods.
- Institutions purchase licenses, which allow students to access courses at no cost to the learners.

#### 2.4 Account Management
